1) <u>General:</u>

Your organization may wish to use the ICL Logo to market itself as a company registered to ISO 9001, ISO 14001, OHSAS 18001 Artwork is supplied Artwork is supplied to you as hard copy strikers and soft copy may be downloaded from our website <u>www.iclcert.com</u>

Where ICL hold EGAC Accreditation for the scope of your registration, you may use either the basic ICL Logo, or the Logo combined with the EGAC Accreditation Mark. However, please observe the following, which will be subject to monitoring by ICL during surveillance visits:

2) <u>Conditions of Use</u>:

- a) Logos may <u>not</u> be used on products, packaging, or other materials, which may suggest product approval, unless this has been granted.
- b) Logos may be used on letterheads, business cards, brochures, advertising material.
- c) There is no restriction as to the size of the basic ICL Logo.
- d) There is no restriction as to the choice of colour of the basic ICL Logo but please do <u>not</u> use more than two colours.
- 3) <u>Conditions for the Combined ICL/EGAC Accreditation Mark Logo</u>:

3.1 Display of the Symbol

- **3.1.1** The Symbol will be displayed only in the appropriate form, and color as demonstrated in figure no. (1) Below. The ICL is entitled to enlarge by a factor of up to 2, if necessary, provided that the original proportion between the height and width of the symbol will not be affected and the symbol is legible.
- **3.1.2** EGAC symbol shall normally have a minimum height of 20mm (excluding EGAC Accreditation No.) and not larger than 25mm. While the width of the symbol shall be minimum 30mm and not larger than 35mm. as Figure 1



3.3.1 Holders of certificates issued by ICL will always use EGAC Symbol in conjunction with the mark of the certification body or certification scheme. As shown in Figure No. (2)

- **3.3.2** ICL will ensure that they audit the use of their combined marks (i.e. the mark of the certification body in conjunction with EGAC Symbol) by their certificate holders. Conditions for the use of the marks by such certificate holders are given below.
- **3.3.3** The conditions detailed in section 2, 3 and 4 apply to such certificate holders.
- **3.3.5** Where a certification body holds more than one accreditation covering the scope of the certification from different accreditation bodies, the certification body is not allowed to use any other accreditation bodies' symbol along with EGAC symbol on the conformity assessment certificate issued by it. However the certification body can issue separate certificate containing accreditation symbol of other accreditation body.



- **3.3.6** if you are in doubt regarding the use of the logo, please contact the ICL office before printing.
- **3.3.7** Upon suspension or withdrawal of certification (however determined), client shall discontinued use of all advertising matter that contains any reference to certification status?
- **3.3.8** Upon suspension of the certification by ICL, the certified client shall immediately cease to use its stationery, certificates and other publicity material that has ICL/EGAC logo on it. The use can be restarted only after the suspension is revoked by the board.
- **3.3.9**. Upon termination of the certification on account of non-renewal/withdrawal of the certified client shall immediately cease to use its stationary, certificates and other publicity material that has ICL/EGAC logo on it.
- **3.3.10** Misuse and Penalty: Misuse of ICL certification logo and / or EGAC accreditation mark would lead to corrective action, withdrawal of certification, publication of the transgression and, if necessary, other legal action.
